On a happy note, we did receive a donation mailed to out box in the amount of 2000.00 on behalf of a member, that's a pretty incredible contribution to our area.

RCM 1 – Karla

I would like to begin by offering my sincere apologies to the area for any confusion caused during a recent area meeting. At that time, I initially stated that subcommittees could vote, then corrected myself to say they could not. I would like to clarify this point:

Subcommittees can vote at the regional level if proposals are listed under New Business. However, they cannot vote on proposals listed under Old Business. Therefore, if the facilitator categorizes proposals as New Business, subcommittees are permitted to vote. I understand there have been concerns in past area meetings regarding subcommittee voting rights, and I hope this explanation brings clarity. Again, I apologize for any earlier confusion.

With that being said, all six proposals presented at the recent regional meeting were passed.

Additionally, the regional treasurer has informed us that the region, along with TBRCNA, is currently facing financial challenges due to rising costs. This trend appears to be affecting NA on as a whole, as it was reported that World Services lost \$900,000 from the most recent World Convention. As a result, there will be no World Convention in 2027.

World Services is encouraging all areas to participate in 24-Hour Unity Day on September 6. Also, please note that the CAR will be released on November 3. A reminder that the Southern Zonal Forum will take place on July 26–27.

(Note: All administrative position elections will be held at the November RSC.) New Proposals to Take Back to Your Homegroups:

• Increase TBRCNA 26 seed money to \$18,000



Rationale: Costs have significantly increased; services and resources previously offered at no cost are now being charged.

• Add an IT budget of \$500 per quarter

Rationale: This aligns with budgets of other subcommittees and will support ongoing IT related expenses.

• Region to pay for damages incurred at RFATX rather than filing an insurance claim

Rationale: A group meeting at the location was responsible for the damages. Failure to pay may result in loss of our insurance coverage.

Please take these proposals back to your homegroups for discussion. I will continue to keep the area informed of any updates.

Poster Day was quite successful! Thanks to those of you that volunteered and went out to spread the good word. We had 17 people attend and volunteer to travel around Austin to put up posters. This number does include my daughter who was more there against her will, but she counts! Becky D still needs reimbursement for the purchase of the posters which was \$312.

We have lots of posters left over for a future event, looking at when it cools off to try one more this year.

So far, from our T-shirt sales, we have raised around \$2,500. Removing the initial cost of \$600, we have \$1,900 of profit to help get the word out about NA.

We purchased 10 extra small and 10 extra medium shirts because those were sold out the most quickly. If you would like one of those sizes, please reach out to Seanfo. He is purchasing these extra shirts with the money we have already made, so no extra money is needed from the area.

We ran into a major snag with the bus placards. A 3rd party company manages all the sales for Cap Metro advertising, and they told us that the minimum order would be \$10,000. This is clearly not possible, so Anne Marie is reaching out directly to Cap Metro to see if we can get in through a public service announcement channel. We are also looking into potentially using the profits to get TV or Radio ads but just beginning to scratch the surface there.

We have registered for the Austin Pride event. Becky D paid for the registration cost of \$388.12. The event is 8/23/25, and we are looking to purchase stickers to hand out at the event along with extra tickets for volunteers that plan to man the booth, and we are asking for volunteers who would be willing to spin the 1's and 2's as the kids say.

Apparently, playing music at last year's event was a big hit, so we are trying it again.



Recovery in the Park takes place Saturday 9/27 at Fair Market in East Austin. Registration is not open yet, but we plan to get a booth there. The event last year was fun, so once we have more information, we will let you know.

Thank you so much to those who volunteered at the area to show up to the poster day, and to those who volunteered to sell shirts. You are all making our work much more possible and enjoyable!
