Scroll down to “ CTANA LITERATURE ORDER FORM JULY 2021” there are 2 of them. The TOP one is for EXEL and the LOWER one is for GOOGLE DOCS. I have not yet figured out the Google Docs access yet so please continue to use the Exel download. Yall have done a great job this month so thank you for that. If you do use Excel, you will have to click the “Enable Editing” tab at the top middle of your screen. Then Tap on “Auto save” at the top LEFT of your screen. Then go to QUANTITY and tap the cursor at the literature that you want IN THE “QUANTITY” COLUMN. Type in number and hit “ENTER” You have to hit enter or it won't save! Repeat the process until your form is filled out. When you are done filling out the form the total will be at the bottom of your order. ( That total goes on your money order) Then go to and tap “SHARE” on the TOP RIGHT screen. A “send link” should pop up in the middle of your screen, scroll down to the bottom of that pop up and tap on “SEND A COPY”. Excel Workbook and PDF will pop up. Pick which one you want and send it to [literature@ctana.org](mailto:literature@ctana.org). If you are waiting on literature from back order please get with me so I can get it to you before the literature is put up. Just a reminder that we will continue filling requests for black key tags with the multilingual key tags until we run out. However, if your group prefers to NOT use these keytags, please be sure to clearly note “ENGLISH ONLY” on your lit order. Currently, we have 486 multilingual multi year keytags in our inventory. Our Policy Subcommittee met on February 27th.

We are in the process of converting much of the language in the current policy, changing / removing sections that will coincide with C.B.D.M.

**1. POLICY DISCUSSION:**

**WHO CAN VOTE?** I will bring up at OPEN FORUM to discuss and decide whether or not to allow ALL TRUSTED servants the ability to participate in consensus. That will include the Administrative body and all subcommittee chairpersons.

**2. I sent out to our Facilitator & Co-Facilitator requirements for C.B.D.M. facilitation:**  
What does the facilitator do?

The role of the facilitator is to help a group or service body reach consensus on an issue. To do this certain actions are required:

- Ensure everyone has a clear understanding of the process being used and the issue being discussed.
- Help everyone to participate, including the quieter members in the room.
- Listen for common ground and points of agreement and share these with the body.
- Repeat ideas that are shared to be sure everyone has a common understanding of them.
- Suggest ways to combine ideas to build consensus.
- Manage the time available and ensure enough is allocated for the proposal.
- Keep the conversation focused and move it forward towards a decision when needed.
- Ensure everyone has a clear understanding of any decisions that are made and any further actions that are required, and that these are recorded.

**3. I sent out the following flowchart and guidelines to all CTANA trusted servants to help educate and simplify the process going forward:**

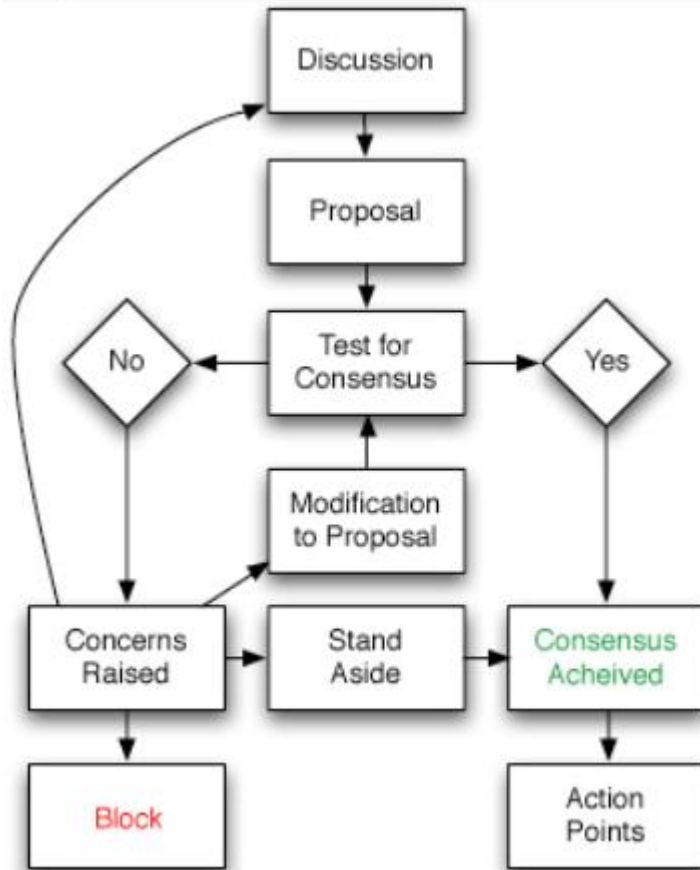
**HOW DOES C.B.D.M. WORK? (Consensus Based Decision Work)**

I have tried to simplify this the best I can so we can all understand it, we feel that as your Policy Subcommittee, it is our job to educate the best we can.

The flowchart below shows each step of the process.

Below the flowchart are descriptions for all the points in the chart.

The better we get, the smoother it goes.  
I hope this helps all of us along the way.

**INTRODUCE PROPOSAL:**

Provide relevant details including:

- Why is the proposal necessary?
- What are the specific objectives of the proposal?
- What human and financial resources required?

Community decision: Who can introduce an idea or proposal? (We decide as an area on this)

- o Most bodies allow only trusted servants to make proposals.
- o In some bodies only delegates (GSRs, RCMs, and RDs) can make proposals.
- o Other bodies will allow anyone present to make a proposal.

**DISCUSS & CLARIFY AS NEEDED:**

Asking questions, sharing resources, and offering experience and ideas are all parts of this phase of the process.

Community decision: Who can speak to an idea or proposal? It's common for consensus-based bodies to allow anyone present to speak, though some recognize trusted servants before hearing from interested members.

**ASK IF THERE IS A CONSENSUS:**

A simple way to do this is to ask the room “Is everyone comfortable with moving forward with this proposal?” If everyone is not in agreement then a show of hands (a straw poll) can be used to determine the level of support.

Some communities take a simple “for” and “against” vote to make a decision.

Others include options such as “agree with reservation” for members who basically agree with the proposal but have some issues that have not been addressed and “stand aside” for members who do not agree with the proposal but will not stand in the way of it passing.

Community decision: What is the threshold for achieving consensus? Some options include: (we decide as an area on this)

- o Two-thirds majority

- o 80%

- o More?

**IF NO CONSENSUS – CONCERNS RAISED:**

This phase allows those not in agreement to share their concerns. All participants are encouraged to listen and offers ideas for modifying the proposal. Not all concerns will lead to changes.

**IF STILL NO CONSENSUS – ACTIONS TO POSSIBLY TAKE:**

- ☐ An effective facilitator can help the body determine when to continue discussion and when to try something else.

- ☐ A simple option is to take a short break or to postpone the decision until the next service meeting.

- ☐ This may be a workgroup or an ad-hoc committee, a number of the service body’s trusted servants, or any other group that has the experience to suggest a way forward. Providing clear guidance to this group is particularly important.

- ☐ Not every idea or proposal is supported, but CBDM allows all participants to be heard and to work together rather than argue opposing sides of a decision.

**WHAT DECISIONS CAN C.B.D.M. BE USED FOR?:**

- ☐ CBDM can be used to hold broader discussions that may not result in a specific decision.

- ☐ Each community is free to determine when a CBDM process will be most effective for them.

- ☐ Elections are one type of decision where it is common to simply seek a majority or a two-thirds vote rather than utilize a consensus-based decision making process.

**Guidelines for Consensus-Based Decision-Making (CBDM)**

1. ASC participants can bring proposals to the body. Only members who are trusted servants can vote.

2. Consensus is defined as 80% or more of the GSR participants in attendance, with each participant having only one vote.

3. Area Chairperson asks the body for clarifying questions about the proposal (not a debate on the merits but a brief session to be sure everyone understands the proposal). All Narcotics Anonymous (NA) members in attendance are welcome to participate in discussion.

4. Area Chairperson asks whether anyone has any reservations about the proposal. These are heard, and they may be answered or the proposal may be amended.

5. When all reservations have been heard and answered in this way, Area Chairperson asks, “Do we have consensus?”

4. Participants respond in one of four ways: (this is how we now vote)

a. Assent: To support the proposal, all things considered. Assent is signified by remaining silent. It may not mean that I'm in

agreement with every aspect, but that I've heard the discussion and had my chance to participate in the process of finalizing the proposal, and am prepared to support it.

b. Assent with Reservation: It is done by raising your hand and simply saying when the facilitator calls on you, "Assent with reservation."; The Facilitator will ask if a participant wishes to share their reservation to be noted in the Record. This is not materially different from Assent, and is the option often left out for that reason, but it is sometimes included as a way of giving people a place to stand when they don't want to object more strongly, but they do want to note that they have reservations.

c. Stand Aside: It is a statement that I do not support the proposal, but my objection is not of the nature or the severity to warrant a block. \*\*\*A common misconception about the stand aside is that it is similar to an abstention. It is not. It is more accurate to say it is similar to a "no" vote.

One of the ASC's guidelines needs to be how many or what proportion of stand asides indicate a consensus too weak to adopt the proposal.

c. Block: Given that a proposal can be defeated by a sufficient number of stand-asides, the block should be an extremely rare step taken only when a participant honestly believes that the proposal is in direct conflict with Traditions or Concepts, or some very fundamental moral position of the participant is violated.

A member who blocks should be able to articulate which tradition, concept, or moral position with which the proposal is in conflict.
