I am going to connect through ZOOM today. I am not feeling well, and I will not bring my snots to area...

I know we are having a spot in time for Q&A on the CAR/CAT. Mostly this is a great opportunity to be heard at the world level. I hope all of the GSRs received the emails with the tally for included, and are ready to cast a vote. If not, and you would like more information, this is the time to ask.

Motion one, Acting as the trustor, the delegates present at the virtual WSC 2022, are continuing the suspension of Article 5, Section 3 of the *FIPT* Operational Rules, while we make a decision about the future. This suspension will expire at the close of WSC 2023.

This motion is asking to have the policy change to reflect the pandemic, and to suspend decisions for the motions until a in person meeting of the RDs, and world delegates. So, pretty simple for moving forward on this motion. It is just like us to table a motion/proposal until we have all the members present for a vote.

Motion two, To extend the terms of the WSC elected positions for the two Human Resource Panel members and one WSC Cofacilitator currently set to expire in 2022 to 2023.

This motion is asking to extend the world services delegate positions of HR panel for another year. This is to let our RDs, and the world delegates to be present for voting in on new HR panel members.

Motion three, To extend the terms of the three WSC elected positions on the World Board currently set to expire in 2022 to 2023.

This is like motion two. The world service would like to extend current positions for another year until they all can meet in person.

Motion four, To approve the book contained in Addendum B, "A Spiritual Principle a Day" as Fellowship-approved recovery literature.

This motion is to approve the new meditation book for world to start pressing! I have had the new book opened in my pages, and I have looked over the days, and the writing. I am pretty excited to have another bit of literature for us to carry

- Cenikor Justin S, Coordinator fulfills this commitment every Sunday at 7 pm
- Rock Springs Michiel R, Coordinator fulfills this commitment every Wednesday @ 6pm; Michiel reports that they are NOT allowing him to bring anyone else in with him at this time.
- Sage Recovery David A, Coordinator fulfills this commitment every Thursday at 6:30 pm. There is a good turnout at this commitment and residents from this facility have been showing up to in person NA meetings upon discharge. Yay!
- Recovery Unplugged Marcos R, Coordinator and Lisa M Co-Coordinator. The next panel presentation will be held on Tuesday April 5th @ 7:30 pm as panel presentations are every other Tuesday.
- Willow Springs Billy G conducted the first panel presentation on March 24th @ 7:00 pm. This presentation is being held every other week with the next panel scheduled for April 7th @ 7:00 pm.
- Recovery Unplugged Detox- We do not currently have a panel coordinator for this facility as there were conflicts with other fellowships being present at the NA scheduled time. However, I was able to communicate with the facility's Business Operations Manager, Brandon Parks whom assured me that NA is currently scheduled for Thursdays @ 7:30 with flexibility to determine frequency. Monica C, H&I Facilitator for CTANA did fulfill this obligation on March 24th @ 7:30 pm with Claire P. The committee will be reevaluating maintaining this obligation for various reasons such as the residents are not obligated to attend, there is no panel leader assigned as of yet, and the committee is receiving various other requests for other facilities.

New H&I Meeting Requests:

- Cedar Creek Hospital 8402 Cross Park Dr; multi-unit facility ranging from adolescents to adults, short-term stay (5-7 days). The requested days are Mondays from 6:30-7:30 pm and Tuesdays from 6:00-7:00 pm. However, Bryana Cruz, Director has indicated that there is flexibility on days and times should we vote in a panel leader; however, we do not yet have a panel leader or a sufficient pool of volunteers. I emailed Ms. Cruz to get additional information about the structure of the meetings, specifically are the clients required to attend.
- New Hope Ranch 11908 Sparks Rd, Manor, TX 78653 has requested that we return to the facility. The facility requests a panel on Mondays from 7:00-8:00 pm with frequency

flexibility. I informed Eric Stein, that I would present this request at our next subcommittee meeting and would contact him with further details as they become available.

Old Business

- Central Texas Treatment Center (CTTC) Men's Kent L, Coordinator for Central Texas Treatment Center (CTTC) has indicated that there is still no response to multiple attempts to contact someone therefore, this meeting is not currently being held.
- TDCJ Halbert Unit-I am in the process of contacting this facility with the hopes of possibly resuming this obligation as TDCJ is now allowing volunteers at their facilities. As this time, I have nothing to report but more will be revealed.
- The H&I subcommittee voted in January to require an orientation every two years. The committee has begun contacting NA members currently on our H&I volunteer list to determine interest in volunteering on an H&I panel and to conduct another orientation for those who are not in compliance with the new policy. On March 27th the committee held another mass orientation and three members of NA attended. The committee suggests that all those who are still interested and need an orientation to please attend our next subcommittee meeting on April 24th @ 3:00 pm in the large room of the Galano Club.
- I contacted Officer Diana Espinoza at Williamson County Jail who has requested literature for the facility. I advised Officer Espinoza that I would present this request at the next H&I subcommittee meeting and would follow up after.
- I spoke with Williamson County Chaplain Renee Morgan, in regards to Narcotics Anonymous possibly providing a panel presentation at the jail. I followed up with an email at her request and attached PDF versions of Behind the Walls and IP 23, Staying Clean on the Outside. According to the Chaplain all interested individuals would be required to submit to a formal background check prior. The jail does not have available staff to fulfill a commitment at this time. However, she did indicate that this is not permanent and that I should contact her at a later time for an update. She also requested literature which I intend on mentioning at the next subcommittee.

New Business

• The issue about H&I funds was discussed and the subcommittee will be presenting possible **solutions** as how to best disburse the \$4353.10 reported on February's Treasurer report. I would like it noted that in 2020 H&I was not allowed in facilities to conduct panel presentations; therefore, there was no need to purchase literature as we had plenty on hand. Furthermore, we are just now resuming presentations at the facilities we currently have and are utilizing the literature on held before we hastily begin to purchase additional literature. I did contact James B, Regional Facilitator for the Tejas Bluebonnet Region for

guidance. James B, indicated that the Adopt an Inmate (AAI) program could utilize funds to purchase and distribute NA literature to include Basic Texts, It Works How and Why, Guiding Principles, Living Clean and the Step Working Guides. James B also indicated that the Houston area is holding an H&I Learning Day on May 21st with the intent to raise funds to purchase NA literature for addicts behind the walls. I intend to present these possible solutions at next subcommittee to be held on April 24th @ 3:30 where more will be revealed.

- Another topic that was discussed is H&I funds disbursement. It was suggested that H&I budget and funds are shared with Public Relations (PR) and Public Information (PI). I reached out to Tony C, CTANA Policy Facilitator for clarification and he indicated that current policy does not indicate that H&I shares its budget with PR or PI.
- CTANA received one inmate letter and that will be distributed by Sunday.

Scroll down to "CTANA LITERATURE ORDER FORM JULY 2021" there are 2 of them. The TOP one is for EXEL and the LOWER one is for GOOGLE DOCS. Richard has figured out a way to open an order form using google sheets. First download literature order form from CTANA Lit downloads, then open google drive and upload excel file, then it should open up in google sheets. If you have any questions about this please get with Richard!

If you do use Excel, you will have to click the "Enable Editing" tab at the top middle of your screen. Then Tap on "Auto save" at the top LEFT of your screen. Then go to QUANTITY and tap the cursor at the literature that you want IN THE "QUANTITY" COLUMN. Type in number and hit "ENTER" You have to hit enter or it won't save! Repeat the process until your form is filled out. When you are done filling out the form the total will be at the bottom of your order. (That total goes on your money order) Then go to and tap "SHARE" on the TOP RIGHT screen. A "send link" should pop up in the middle of your screen, scroll down to the bottom of that pop up and tap on "SEND A COPY". Excel Workbook and PDF will pop up. Pick which one you want and send it to literature@ctana.org.

If you are waiting on literature from back order please get with me so I can get it to you before the literature is put up.

Just a reminder that we will continue filling requests for black key tags with the multilingual key tags until we run out. However, if your group prefers to NOT use these keytags, please be sure to clearly note "ENGLISH ONLY" on your lit order. Currently, we have a few hundred multilingual multi year keytags in our inventory. Whenever possible, please order key tags and pamphlets in sets of 10.
