#### Good afternoon,

Please find my comments in red regarding the request for changes to the June's minutes. If further clarification is needed, please take them directly to the July's ASC. Prior to approving the minutes is where all edits may be discussed as needed. No other corrections will be made prior to July's area. I will make the edits as needed listed below and send an updated version.

Page 3 Under Administrative Body Reports from Facilitator, Victor F. states:

The July area will not meet at 5555 N. Lamar Blvd., Suite J-103. This is directly conflicted on page 6 where it states: Area will meet virtually and in-person at 5555 N. Lamar, Suite J-103.

Please clarify: the word **not** has been removed. Correction to be made.

**Page 4** Says that Ruben provided a website to review all items that were discussed at the WSC but then it directs readers to NA.org. Please provide the website that Ruben provided as NA.org is too vague.

The page he discussed can be found on NA.org that is where all material can be found for the WSC under tabs listed on the top of the site. Here is the specific page https://na.org/?ID=conference-index. <u>I will add the link, verbiage will remain as it.</u>

Under Subcommittee Reports, Common Welfare, please indicate that the Introduction to Common Welfare Subcommittee flier was a draft, It was reported as Complete in the CW report. It was not mentioned that it was a draft until the proposal to dissolve the subcommittee (during discussion was being conducted). I will not change the verbiage, I wrote the minutes from the reports that were submitted by the facilitator of each subcommittee. I would be altering what was reported. A change can only be made if asked by the facilitator for information to be amended. That did not occur. as its submission to ASC was directed by the Co-Facilitator, Monica after being emailed to her for review and ideas. The co-facilitator suggested to the subcommittee (CW) report all items that were discussed at the subcommittee to the area. This was stated during discussion regarding the flyer when clarifying questions were being asked and answered during the time the proposal was on the floor. No changes will be made.

This area of the report also states:

Patsy P. submitted a proposal to dissolve the Common Welfare subcommittee based on violation of Tradition 8 and Tradition 4. (Consensus was to take the proposal back to the home groups).

There was no mention of Tradition 4 in Patsy's complaint (concerns) or in the email submitted from Ron. <u>Tradition 4 will be removed.</u>

<u>Change will be made</u>. Tradition 8 was mentioned and discussed as it pertains to the Introduction Flier *Draft*. The Introduction Flier Draft is not the verbiage in the Facilitator's report.

It was submitted by Patsy in the middle of a subcommittee report and not during New Business later in the meeting. Per the CTANA policy, section 3.1 anyone can make a proposal. No time frame is specified. The proposal was made after concerns were addressed. The Facilitator acknowledged the proposal and per CTANA policy 3.3 body was asked for clarifying questions and discussion was held. Facilitator asked Ruben, AD if he would like to add a Point information? Which was done.

It caused quite the disruption and when Common Welfare was finally asked if they would like to respond, they stated that they would need a week and that it would be in writing. Per policy 3.3 no pro vs. con debate is permitted, this was stated by the Facilitator. While the Facilitator said, the Facilitator of CW could respond, he was out of order for stating that per policy.

There was no consensus made as there was no vote called for. This statement is not correct. A consensus was reached to take the proposal back to their home groups based on discussion and concerns over the magnitude of the proposal.

Please adjust this to represent what actually happened. We can not take this back to the home groups without Common Welfare having had a chance to respond. Facilitator made this statement: CW does not get to respond based on Consensus based decision making process.

While the facilitator said she could respond, it is not the proper process per policy. There was a consensus to take the proposal back to the homegroups and return prepared to hold a consensus at the July's area. See CTANA policy, section 3., specially section 3.3.

Page 6 After Victor resigned at 4:50, Monica asked (tasked) Ruben to step in (assist) and help her. Many people had walked out at this point and no one voted to meet consensus on Ruben's participation. I think we were all too disheveled about the disruption. There was talk of taking roll-call again but Monica made the decision to conclude Area at that time and it was closed out with the third step prayer. Area did not continue. This is not an accurate statement.

Please adjust. At 5pm a second roll call was taken and 19 were present, consensus was met and business was continued. <u>Change will not be</u> made.

Anything on the agenda after this point did not happen. There were no group reports read as stated in the minutes and the Old Business is entirely false. Groups did read the reports as listed in minutes, change will not be made.

Old Business will stay as written, no changes will be made. As stated early, at 5pm a second roll call was taken and 19 were present, consensus was met and business was continued

Andrea's proposal was made in April with the amendment and was voted down that same day. It is no longer in play to be talked about or voted on to my understanding. Statement is not correct. She was asked if she would accept this proposal being carried another month. Per Co-Facilitator this is correct that the proposal was moved to July's Old Business. No Changes will be made.

Patsy's proposal should not be in Old Business as it was brought up during a subcommittee report and not at the prior ASC. This statement is not correct. <u>CTANA policy, section 3.1 states anyone can bring a proposal, no time frame is given. Proposal was addressed at June's area so it is considered Old Business.</u> No corrections will be made.

Please adjust Old Business correctly. No corrections will be made.

New Business, Elections and Announcements are correct, thank you. Technically, there was no new business from June's ASC meeting. Patsy Pena

This is interesting. I read it through a few times, really trying to ask myself objectively what concerns this raises. I have never seen this formally done before so I'm trying to make sure that I'm not just reacting to something new. Here's where I land after some thought.

I think my main concern is around the 8th tradition, and then it is really mainly about them offering the service of mediation. It is fundamental to the nature of NA that our approach is non-professional, that we claim no professional expertise in the services we offer and perform. The asset that we are bringing to bear is "experience, strength and hope" regarding recovery from addiction. This mediation function seems outside of those bounds. Mediation is a violation of Tradition 8, we are not professionals nor do we provide professional services.

To name the problem they are addressing "predatory behavior," (a highly charged phrase should someone who is really only flirting or seeking to date get that label) and then offer mediation services between someone who was made uncomfortable by the advances of the alleged "predator" seems to me to be asking for the kind of powder keg of charged feelings that would require professional expertise and standing to navigate. I'm not saying that actual predatory behavior does not exist in NA, but for someone to set themselves up as the arbiters and mediators of complaints about it seems to me like an overreach. In their "what we aren't" section, they say they're not the NA police. It seems to me that this claim would preclude any reporting of people to them followed by some action they would take with the alleged perpetrator.

The other services seem fine for the most part. Workshops designed to raise discussion and awareness about what's appropriate in the NA context and what starts to feel to some members like exploitation could add value in an area. In fact, exploitation might be a better word than the phrase predatory behavior in general. I know this phrase has gained traction in NA, but I believe it is a mistake for us to lead with it if we are actually meaning to include the less egregious boundary violations or clumsy attempts to flirt or date that I think it may be meant to include.

Accompaniment could be a valuable service. If someone felt uncomfortable and requested that someone accompany them to a meeting, that seems possibly quite valuable.

To have a set of members who have studied the available NA materials and history of other areas' experience on this topic serve as an information source and support seems potentially valuable as well. This service of being each others eyes and ears and watching out for potential exploitation of the vulnerable is usually done organically by experienced members if it is done at all. More experienced members are encouraged to speak up when they see it and speak about it to potentially vulnerable newcomers and our own sponsees who may be acting inappropriately. Being a catalyst for a more intentional approach to that kind of thing within our culture could be valuable. To be a sort of court, however, where this function is assigned to a given set of trusted servants who take direct action to address it seems to me to be a potential overreach that the 8th tradition would steer us clear of.

Finally, creating locally produced service literature is not considered entirely out of bounds in NA. I say this having served on the NAWS "Service Materials Workgroup" some years back, where this was discussed at

length and then discussed at the conference. It should be approached with caution, however, with preference given to existing conference or board approved materials where they exist. And review and approval of anything produced locally should be really intensive, as it is at the world level, especially with a topic this sensitive. Nothing about getting elected to serve on a subcommittee makes a small group of members equipped to write and publish literature on a topic like this that reflects group conscience. If they are going to do this, they should circulate drafts and seek a strong approval at the area level before asking groups to distribute it.

That's probably more than you are looking for, and of course it is only one member's opinion and experience. I have no objection to you sharing it if it furthers discussion on these important topics.
