- Roll call taken by Co-Facilitator

 - Shawn visitor
- Question about last month's minutes no corrections, minutes approved.
- Section 2 of CTANA Area Policy read.
 - o 2 minutes for proposal, 8 minutes for discussion
- Facilitator report (Monica C)
 - o Request for \$100 Facilitator budget approved
 - Any time there is a change in the office of the treasurer, there shall be an audit of the office of the treasurer and ASC's financial records
 - Audit scheduled Sunday 12/10/23
 - Request for \$20 room rental fee at RFATX approved
- Co-Facilitator report (Sean F)
 - o Please announce subcommittee meetings, lots of service positions available
 - Paragraph quoted from Guiding Principles
 - No budget
- Recorder (Alex F) absent with notice
- Treasurer James (September report)
 - Quarter 3 taxes upcoming
 - Asking for budget of \$70 for booklet of deposit slips (just for this month, not annual)
 - Stephanie and Richard assent with reservation, Treasurer will check for cheaper online
 - Approved
 - Question about H&I donation
 - Earmarking? Refer to policy no donations accepted that are earmarked for any subcommittee
 - Suggestion to buy books for lit bank and give to David approved
 - o Todd − we have \$8000 in bank account? NOT prudent − can we send money to world or region?

- Cleto \$8000 at beginning of meeting, look at it after agreed
- RCM I Cleto
 - o Stepping down, David (RCM II) will step into RCM I
 - o Proposed budget rolls over from last year to this one
 - o World Convention is 11 months away registration currently on sale
 - Received email from RD on surveys (H&I basics) please complete these!! (open to everyone)
 - Question modify report to include lack of budget?
 - Question where is the survey?
 - Links posted on CTANA website and Area Facebook page
 - Ruben noted that these surveys have been in his report for several months

 - Have gone through prudent reserve and are struggling to pay rent (\$300/mo) is there an option for help from Area? Also considering changing format for certain days (does not need to be submitted to Area)
 - Cleto Just for Today \$100 donation to Area
 - o Cleto Non Fiction Addiction treatment center attendance, donating \$40
 - Allen GSR for Freedom Group (Sundays) made first lit order, donating to Area

Open Forum

- Region PR Facilitator Patsy P 7 min timer to explain IDT (Issue Discussion Topics)
 - There's a 2nd survey in addition to the one listed by Cleto environmental survey aimed at changing service structure
 - Also, individuals and subcommittees can complete the surveys, not just groups
 - H&I due 11/15, environmental due in March CORRECTED H&I is in March, environmental is in November
 - Workshops 10/7 for region in New Braunfels 10 a.m. to 2 p.m. virtual and in-person, all are welcome, important to attend to pass on information
 - Gender-neutral and inclusive language
 - Disruptive and predatory behavior
 - Will have breakout groups
 - o All results will be submitted to NAWS
 - Two other upcoming workshops as well

Old business

- O Rhythm of Recovery update from PR they spoke to Paul, who declared that they do not want to be listed on meeting scheduled
 - Consensus achieved matter resolved
- Concern from Allen E issue with section 3.1.1 and 3.1.2 of Policy (timing of proposals)
 - Some things need to be addressed at the time they come up
 - Question withdrawn addressed by 3.1.2
 - Suggestion from Facilitator to change proposal deadline from 5 days to 7
 - Leonard should it be 8?
 - Kent how can general members find Policy?
 - Will be listed online
 - Geo clarification current Policy is already available for download on website, amended Policy from today will be posted after meeting
- New business (2/7 time limits)

- David A proposal that CTANA alter policy to allow H&I to purchase and distribute keytags in facilities (especially longer-term) using H&I funds
 - Richard World said H&I only gives out lit, not tags why would we do that?
 - Allen does our Policy prohibit subcommittee from purchasing keytags?
 - David we tried to order, and that request was denied (2-3 months ago) by body; so that that doesn't happen again, asking for Policy change
 - Would come out of budget
 - Kent as member of H&I World H&I pamphlet says don't, but email from Bob from World says many H&I programs DO bring in keytags; most important thing is to follow guidelines from the facilities themselves; World guidance of not doing that is only a suggestion, not a hard-and-fast rule
 - Facilities are actively asking for keytags, and many have already approved them
 - Neal if we don't have a policy prohibiting it, the subcommittee should be able to spend their funds however they see fit
 - Stephanie would it be more prudent to make a specific order with specific keytags?
 - Kent Area previously said NO, despite widespread support even groups are offering to pay for it
 - Robert Mitchell wouldn't that be breaking traditions, since it's promotion rather than attraction, since that's not technically an NA meeting?
 - Kent it is an H&I NA-only meeting, so it IS an NA meeting, and we pass out NA textbooks, etc.
 - Tom his homegroup's concern was keytags being used for injury other areas have done business card keytags, which are also cheaper
 - David asked coordinators, and they specifically wanted the actual keytags, not a substitute
 - Richard clarification, NAWS does sell chips
 - David re-read proposal, roll taken again
 - Policy chair would be inserted in H&I subcommittee section 6.6
 - Consensus?
 - o David (as GSR) Regeneration X is a stand-aside
 - o Todd could affect NA as a whole, but stand-aside
 - o Robert Mitchell stand-aside
 - → Proposal passes

- Kent clarify in Policy how funds from H&I book drive and holiday function should be used
 - Suggestion to H&I book drive funds must be deposited to Area account immediately ("conduit" in accounting terms), then turn around and buy books immediately
 - Policy Chair Section 14 no earmarking; 6.4.d.6 Holiday Function (H&I and PR) will be held specifically as a fundraiser for literature
 - Restatement of policy amendment to Policy
 - Ann Marie current Policy states that PRIOR policy (before 5/23) stated that funds went to PR – why was decision to amend Policy made?
 - Kent when there used to be an Activities policy, he asked at Area; isn't asking for any edits, just wants clarification
 - Leonard (Free At Last) group wants to ask for a modification to refer Section 14 earmarking policy back to 6.4 as an EXCEPTION
 - Rejection by Kent, should be addressed in other format
 - Leonard's amendment suggestion change 14 to say that, instead of no donations, no donations OTHER THAN those in 6.4
 - Kent agreed
 - Will be emailed to ASC
 - Allen to answer Ann Marie, policy was changed in early 2000s because PI was struggling, used to be separate, was changed to help them
 - Suggestion of amendment to wording of proposal any funds collected at H&I book drive table only go to H&I AT THE FUNCTION. Anything 7th Tradition or otherwise needs to go to Area.
 - Kent confirm, 7th goes to Area funds, Leonard's amendment is a given
 - Facilitator –clarification: two separate Policy amendments?
 - Allen amending proposal AND Policy
 - 14.18 and 14.5 (Leonard) amend to refer back to 6.4? Yes, Leonard will write up and send out
 - 6.4 (Allen) Kent agreed, remove last 3-4 words re: PR/H&I budget
 - This seems to require more discussion request for Kent to send out agreement with Allen, Leonard to send out his amendment

- Moved to next ASC Old Business after resubmission of proposal; discussion closed.
- Richard (Lit Bank) move Lit Bank from subcommittee to Admin Body (function like Treasurer) – doesn't want to write a policy, but is a proposal to change Policy eventually
 - It's a financial position, so doesn't like the ability to arbitrarily appoint lit bank chair
 - Geo not opposed, but concerned about Lit Bank assistant, which is an appointed position will that also be an Admin Body position?
 - Yes
 - Richard will need to draft and present proposed Policy change for next Area
 - Tim which section? Would be Section 5
 - Todd why is there nothing in writing? Needs that to take back to group there should be a clear, short-form written proposal
 - Monica pulled it up (was sent out last Area in Lit Bank report)
 - Todd what's the intent?
 - Richard financial part, since Lit Bank Facilitator will be able to order directly from NAWS
 - So Co-Facilitator should be elected by Area instead of Chair? YES
 - Robert Mitchell didn't we discuss this last Area? If they're not handling money...?
 - Richard they can order stuff from NAWS and ship it to their house
 - Facilitator so proposal is to move Lit Bank to Admin Body? Policy will be written up and finalized at next Area
 - Tim needs to be clearly written down before we approve
 - Richard does it need to be a Subcommittee policy, or an Admin Body policy?
 - Facilitator consensus yes that it will be moved to Admin Body, but Richard will get with Policy to draft detailed proposal for approval next month
- Subcommittee reports
 - O Activities (Kevin) last year's projected budget, amended with money spent + events held budget total is itemized in report, total is \$4,900 (Angela totaled)
 - Sunday meeting of subcommittee changed to hybrid, will need to pay for space (rent) as well, adds \$20/mo → \$240 more
 - \$5240 is therefore the total

- Note for next area need a storage facility (subcommittees should discuss shared space)
- Consensus report and budget approved
- Note Kevin's separate proposal, submitted after deadline, will be added to next Area
- Common Welfare (Angela O) met 9/18, 9 people in attendance, working on policies and handout, holding workshops on predatory behavior, will attend SZF workshop, planning to work with PR on IDT on gender-neutral language
 - Budget total in report requesting no money for this month, just budget
 - Todd per Policy, discussion of budgets and Area consensus on them are out of order – subcommittee chairs should submit budgets to Treasurer, then Treasurer should give a full report of all budgets
 - Report approved
- H&I (David) budget emailed to treasurer, needs co-coordinators for various treatment facilities
 - Changed H&I policy in August to allow H&I people to sponsor addicts in facilities, just don't show favoritism
 - All facility-specific info is in report
 - Not requesting funds for this months
 - Robert Mitchell question about previous change to policy re: sponsorship
 - David clarification applies more to ex. if you had a sponsee relapse, you can still go into that facility while they're there
 - Kent was there clarification on budget?
 - David Lit coordinator found something in minutes specifying that budget was approved as-is, but does not specifically say what that is, so they assumed current \$12,000 operating budget; will distribute those minutes
 - Michael what procedure do you have to go through to be a cocoordinator?
 - Oriented last few years, approved by official coordinator, 6 month minimum cleantime in general for H&I, but facility-specific
 - Diane clarified which facilities need co-coordinators
 - Consensus, report accepted
- Literature Bank (Richard) NAWS order is not correct [recording illegible]
 - Needs help day of Area, stays open first half of Area
 - Contacted NAWS re: shipping price issue, but total is correct
 - Expenses/spending and budget are in report
 - Is requesting money
 - James (Treasurer) inventory is already over \$5000?

- Richard yes That's the only order, and there is no lit policy or inventory cap
- Kent confirming, is there a limit on the account?
 - Richard there is a limit, unless approved by area, of \$2500 last order was over \$3000, for next year she (who? unclear) will train another person for H&I lit so there is no need for large order
- No other questions, consensus report accepted
- o Policy Chair nothing to report
- Facilitator requests that, since Policy report will be the modifications discussed and 3 proposals for next Area, please email all of that to asc@ctana.org
- Public Relations (Ann Marie) poster day, there are extras and will sell do's and don'ts for distributing, partnering with CW for inclusive language workshop and disruptive/predatory behavior workshops
 - Large lit order no order in last year and a half, so have a large order don't have access to funds, so how do they order?
 - All lit orders go to lit bank, which Richard will submit to Treasurer
 - Ann Marie they sent order to ASC with report. Approx \$500.
 - o Richard will take a look and see if it's fillable today
 - Requesting reimbursement for poster day (\$337.91) + \$489.78 (lit) → \$827.69
 - Report accepted
- Allen reminder that he (Freedom Group) submitted proposal today re: excess ASC funds
 - Forward 50% of surplus funds after bills, reimbursements, expenses, prudent reserve, etc. to NAWS and Region (70%/30% split respectively)
 - Leonard do we have a policy on excess funds?
 - Tim no
 - Kent to Allen is this a one-time thing?
 - Allen yes, one-time disbursement since we currently have an excess of funds.
 - Kent will this leave enough funds for holiday event?
 - Treasurer suggestion to modify since we're already paying quarterly taxes and TBRNA donation, double TBRNA amount and send to World this month (one-time extra donation)
 - Consensus? Yes
